- iv. Where a student gives notice in writing less than four (4) weeks prior to the commencement of that trimester or the specified date for commencement of a program, they will be entitled to a refund of Tuition Fees paid for the trimester, less fifty per cent (50%) of the prescribed trimester fee.
- v. Where a student gives notice in writing of the cancellation of enrolment in a course more than four (4) weeks after the start of the course no Tuition Fees are refundable.
